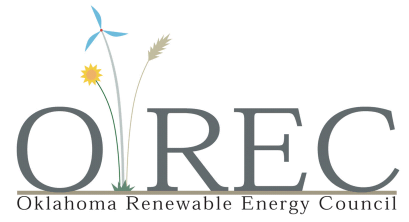


# Oklahoma Renewable Energy Council Membership Application

OREC Membership runs on an annual basis based on a calendar year from January 1<sup>st</sup> to December 31<sup>st</sup>. For the 2013 calendar year, membership dues will provide for a valid membership for July 1, 2013 until December 31, 2014. Beginning January 1, 2014, membership dues will be valid for the calendar year of 2014. Payment of membership dues can be made via cash, check or purchase order.
